- Assisted in developing a research agenda exploring governance interventions engaging community and local institutions, focus on developing more realistically complex yet testable causal accounts
- **Kenya (2021):** Co-lead researcher (with Ryan Sheely) for a study in Kenya, examining effects of participatory budgeting on political economy at ward and county level, examining whether corrupt behavior is marginally constrained at smaller geographic units, due to increased visibility and/or normative pressure to provide for more proximate in-groups (e.g. village vs. county)
- **Myanmar (2020-2021):** Lead researcher for a national-level study on local governance in Myanmar during COVID response and 2020 national elections, focused on democratic norms and social cohesion at ward and village level. Trained and managed a research team to conduct longitudinal interviews of local governance leaders (n=115) across three waves. Coding and analysis using NVivo. In partnership with the Centre for Good Governance.
- **Nigeria and Afghanistan (2021):** Co-author for a comparative report on COVID's effects on governance institutions and conflict in Afghanistan, Nigeria, and Colombia
- **Myanmar and Jordan (2020-2021):** Co-PI for a £100,000 grant (with Reva Dhingra and Ryan Sheely) awarded from Centre of Excellence for Development Impact and Learning for a comparative study of governance trainings in Myanmar and Jordan. *Not completed — suspended due to coup Feb. 2021*
